

Count 26 - Theft - on or about April 20, 2009, - (D & D)

Willfully and unlawfully commit theft of money or property have a value of \$1,000.00 or greater, belonging to the State of Louisiana, the citizens of Ouachita Parish and/or various taxing entities of and within Ouachita Parish, contrary to the provisions of R.S. 14:67.

Count 27 - Theft - on or about October 20, 2008, - (State of Louisiana Check)

Willfully and unlawfully commit theft of money or property have a value of \$1,000.00 or greater, belonging to the State of Louisiana, the citizens of Ouachita Parish and/or various taxing entities of and within Ouachita Parish, contrary to the provisions of R.S. 14:67.

Count 28 - Theft - on or about February 4, 2008, - (Top Gun)

Willfully and unlawfully commit theft of money or property have a value of \$1,000.00 or greater, belonging to the State of Louisiana, the citizens of Ouachita Parish and/or various taxing entities of and within Ouachita Parish, contrary to the provisions of R.S. 14:67.

Count 29 - Theft - on or about Jan 1, 20, 2008 through May 1, 2009 both dates inclusive, - (Special Events)

Willfully and unlawfully commit theft of money or property have a value of \$1,000.00 or greater, belonging to the State of Louisiana, the citizens of Ouachita Parish and/or various taxing entities of and within Ouachita Parish, contrary to the provisions of R.S. 14:67.

Count 30 - Theft - between April 1, 2008 and July 30, 2008, - (Highshaw)


Willfully and unlawfully commit theft of money or property have a value of \$1,000.00 or greater, belonging to the campaign for Wince Highshaw, Jr., candidate for Monroe City Marshall and/or Azim S. Jalaldin, contrary to the provisions of R.S. 14:67.

Count 31 - Racketeering - between January 1, 2004, and May 1, 2009, both dates inclusive;

Willfully and unlawfully commit the offense of Racketeering by being associated with an enterprise knowingly conduction or participating in such enterprise directly or indirectly through a pattern of racketeering activity, in violation of the provisions of R.S. 15:1353.
