WHEREAS, the Louisiana Department of Transportation and Development (LA-DOTD) has proposed an Agreement with the Ouachita Parish Police Jury to facilitate a project for the construction of sidewalks in the area of Shady Grove Elementary School in Ouachita Parish, said project being identified as State Project No. H.009297 and as Federal Aid Project No. H009297; and,

A RESOLUTION MAKING CERTAIN CERTIFICATIONS WITH RESPECT TO CERTAIN "GUSTAV/IKE PROJECTS" BEING FUNDED THROUGH THE COMMUNITY DEVELOPMENT BLOCK GRANT DISASTER RECOVERY ("CDBG-DR") INFRASTRUCTURE PROGRAMS; AND FURTHER PROVIDING WITH RESPECT THERETO.

WHEREAS, the Ouachita Parish Police Jury has submitted applications for funding under the Community Development Block Grant Disaster Recovery (CDBG-DR) Infrastructure Program for certain projects necessary to alleviate flooding hazards in Ouachita Parish, Louisiana, which are hereinafter referred to collectively as the "Gustav/Ike Projects";

WHEREAS, included among the Gustav/Ike Projects are drainage improvements in the Wellerman Road area of the City of West Monroe and drainage improvements in the Highland Subdivision area of the Town of Sterlington, all in Ouachita Parish, Louisiana;

WHEREAS, the Department of Housing & Urban Development regulations require that the Ouachita Parish Police Jury certify that these activities for which CDBG funds are being requested are designed to alleviate existing conditions which pose a serious and immediate threat to the health or welfare of the community; which are of recent origin or which recently became urgent, and that the Ouachita Parish Police Jury is unable to finance on its own, and that no other funds are available;

NOW, THEREFORE:

BE IT RESOLVED that the Ouachita Parish Police Jury hereby certifies that the activities for which CDBG funds are being requested for the drainage improvements to be made in the Wellerman Road area of the City of West Monroe and in the Highland Subdivision area of the Town of Sterlington are designed to alleviate existing conditions which pose a serious and immediate threat or welfare of the community; are of recent origin or which recently became urgent and that the Ouachita Parish Police Jury is unable to finance the activity on its own and there are no other funds available for said projects.
