Recommendation of Award MML&H File No. 7239-010

Dear Mr. Hall:

This morning bids were received in connection with the North Louisiana Exhibition Center Addition project to add the Warm Up Arena. Nine (9) bids were received for the project with the lowest base bid being submitted by Pro-Build Construction, Inc. from Homer, Louisiana for the Base Bid amount of \$502,215.00. Their bids for Additive Alternates Nos. 1 and 2 were \$13,025.00 and \$4,896.00 respectively. The total bid for the base bid and both alternates is \$520,136.00.

A certified tabulation of all bids received is enclosed. The lowest bidder has a valid Louisiana Contractor's License, valid bid bond, and has completed previous projects of a similar scope and nature in the State of Louisiana including the original construction of the Exhibition Center's 3 contracts. Therefore, we recommend that the project be awarded to Pro-Build Construction, Inc. in the amount of \$520,136.00 subject to the satisfactory receipt of all forms and information required under the contract provisions. If the Police Jury concurs with this recommendation, please have the Police Jury authorize the award of the contract and allow you to sign all award related documents.

When the project began, the Covered Warmup Arena was to be 230' X 230'. When the project budget was reviewed, Meyer, Meyer, LaCroix & Hixson, Inc. contacted three contractors to evaluate the ability to construct the project within the available funds. The consensus was that the project construction cost would be between \$900,000 and \$1.2 million. MML&H, Inc. recommended reducing the size of the building to 160' X 230' to get it within the available funds. With the interest in the project among local contractors and the low bid prices, it will be possible to add some of the original square footage back to the project by a change order. A preliminary discussion with the low bidder indicated that this could be done at approximately the same cost per square foot of the project as bid, approximately \$14.00/SF or an additional cost of \$128,800. A project budget showing the cost of returning the Covered Warmup Arena to a 200' x 230' footprint would bring the project budget to \$806,911. If the Police Jury would like to pursue this change order, this can be negotiated and presented at the next Police Jury meeting for approval.
