SUBJECT: Resolution Canvassing Returns and declaring the results for the

election held in Lincoln Parish held on Saturday, August 15, 2020.

Background

The Lincoln Parish School Board at its October 1, 2019, Board Meeting voted to call a special election to seek authorization to collect one-half of one percent sales tax in Lincoln Parish. Governor John Bel Edwards rescheduled that election, originally scheduled to occur May 9, 2020, because of the advent of the Covid Pandemic. Governor Edwards changed the time for the election to the later date of August 15, 2020. After any election authorizing school board collection of taxes, the Board must (1) vote on a resolution providing for a canvassing of the returns and declaring the results. In addition, (2) the Board should adopt an ordinance providing for the levying of the one-half of one percent sales and use tax as authorized by the outcome of the election.

Recommendation

That the Lincoln Parish School Board vote (1) to adopt the Resolution to declare the results of the August 15, 2020, sales tax election and (2) vote to adopt an ordinance providing for the levying of the tax.

RESOLUTION

A resolution providing for canvassing the returns and declaring the results of the special election held in the Parish of Lincoln, State of Louisiana, on Saturday, August 15, 2020, to authorize the levy of a sales and use tax therein.

BE IT RESOLVED by the Parish School Board of the Parish of Lincoln, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of Lincoln, State of Louisiana, for school purposes (the "Parish"), that:

SECTION 1. <u>Canvass</u>. This Governing Authority does now proceed in open and public session to examine the official tabulations of votes cast at the special election held in the Parish of Lincoln, State of Louisiana, on SATURDAY, AUGUST 15, 2020 (the "Election"), to authorize the levy of a sales and use tax therein pursuant to the following proposition (the "Proposition"):

PROPOSITION (SALES TAX)

Shall the Parish School Board of the Parish of Lincoln, State of Louisiana (the "School Board"), be authorized to levy and collect a tax of one-half of one percent (1/2%) (the "Tax"), in perpetuity, commencing July 1, 2020, upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption of tangible personal property and on sales of services in the Parish of Lincoln (the "Parish"), all as provided by law (an estimated \$4,600,000 reasonably expected at this time to be collected from the levy of the Tax for an entire year), with the proceeds of the Tax (after paying the reasonable and necessary costs and expenses of collecting and administering the Tax), to be dedicated and used for the purpose of giving additional support to the public elementary and secondary schools in the Parish, including, but not limited to: (i) providing enhanced security at all public schools and facilities in the system, including a school resource officer (SRO) at each school, which SRO shall be a commissioned law enforcement officer and (ii) salaries and benefits of teachers and other public school employees?

This Governing Authority does further proceed to examine and canvass the returns of the Election thereof.

SECTION 2. <u>Election Results.</u> According to the official certified tabulation of votes cast at said Election, there was a total of 2,373 votes cast IN FAVOR OF the Proposition and a total of 2,070 votes cast AGAINST the Proposition, resulting in a majority of 303 votes cast IN FAVOR OF the Proposition. The Proposition was therefore duly CARRIED by a majority of the votes cast by the qualified electors voting at the Election.

SECTION 3. <u>Promulgation of Election Result.</u> The results of said election shall be promulgated by publication in the manner provided by law, only after receipt from the Secretary of State's office of the actual costs of the election, as required by Act 205 of the Regular Session of the Legislature of Louisiana for the year 2019.

SECTION 4. <u>Declaration</u>. The foregoing results of the Election are hereby declared by this Governing Authority and shall be published as required by law.

SECTION 5. <u>Procès Verbal</u>. A *Procès Verbal* of the canvass of the returns of the Election shall be made and a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in his office; another certified copy thereof shall be forwarded to the Clerk of Court and *Ex-Officio* Recorder of Mortgages in and for the Parish of Lincoln, who shall record the same in the Mortgage Records of said Parish; and another copy thereof shall be retained in the archives of this Governing Authority.

Pursuant to the provisions of a resolution adopted by the Parish School Board of the Parish of Lincoln, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of Lincoln, State of Louisiana, for school purposes (the "Parish"), on October 1, 2019, NOTICE IS HEREBY GIVEN that a special election will be held within the Parish on SATURDAY, MAY 9, 2020, and that at the said election there will be submitted to all registered voters in the Parish qualified and entitled to vote at the said election under the Constitution and Laws of the State of Louisiana and the Constitution of the United States, the following proposition, to-wit:

PROPOSITION (SALES TAX)

Shall the Parish School Board of the Parish of Lincoln, State of Louisiana (the "School Board"), be authorized to levy and collect a tax of one-half of one percent (1/2%) (the "Tax"), in perpetuity, commencing July 1, 2020, upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption of tangible personal property and on sales of services in the Parish of Lincoln (the "Parish"), all as provided by law (an estimated \$4,600,000 reasonably expected at this time to be collected from the levy of the Tax for an entire year), with the proceeds of the Tax (after paying the reasonable and necessary costs and expenses of collecting and administering the Tax), to be dedicated and used for the purpose of giving additional support to the public elementary and secondary schools in the Parish, including, but not limited to: (i) providing enhanced security at all public schools and facilities in the system, including a school resource officer (SRO) at each school, which SRO shall be a commissioned law enforcement officer and (ii) salaries and benefits of teachers and other public school employees?

Said special election will be held at each and every polling place in the Lincoln Parish, which polls will open at seven o'clock (7:00) a.m. and close at eight o'clock (8:00) p.m., in accordance with the provisions of La. R.S. 18:541.

The polling places at the precincts in the Parish are hereby designated as the polling places at which to hold the said election, and the Commissioners-in-Charge and Commissioners, respectively, shall be those persons designated according to law.

The estimated cost of this election as determined by the Secretary of State based upon the provisions of Chapter 8-A of Title 18 and actual costs of similar elections is \$48,000.

The said special election will be held in accordance with the applicable provisions of Chapter 5, Chapter 6-A and Chapter 6-B of Title 18 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority, and the officers appointed to hold the said election, as provided in this Notice of Special Election, or such substitutes therefor as may be selected and designated in accordance with La. R.S. 18:1287, will make due returns thereof to said Governing Authority, and NOTICE IS HEREBY FURTHER GIVEN that the Governing Authority will meet at its regular meeting place, the Parish School Board Office, 410 S. Farmerville Street, Ruston, Louisiana, on TUESDAY, MAY 12, 2020, at SIX O'CLOCK (6:00) P.M., and shall then and there in open and public session proceed to examine and canvass the returns and declare the result of the said special election.
